Current position: Among other positions, he was the Regional Advisor for Environmental Policy in the Division for Sustainable Development and Human Settlements of the Economic Commission for Latin America and the Caribbean (ECLAC); Director of "Systems for Sustainable Development" Program in the Stockholm Environment Institute (SEI), Stockholm, Sweden; Leader of Land Management Program at the International Center for Tropical Agriculture (CIAT), based in Cali, Colombia; Senior Fellow at the International Institute for Sustainable Development (IISD), Winnipeg, Canada; Senior Expert on Environment and Development "at the International Institute for Applied Systems Analysis (IIASA), Austria; Full Professor at both the University of Buenos Aires and the Bariloche Foundation in Argentina, as well as Executive Chairman and Chairman of the Board of Bariloche Foundation. It is one of the founding members of the "New World Dialogue on Environment and Development" and "Inter-American Group for the Sustainable Development of Agriculture and Natural Resources." Until early 1991 he directed the Systems Analysis Ecological Group (Argentina). Has been one of the authors of Latin American World Model, and is co-coordinator of Global Scenario Group (GSG).

She has conducted research, consulting and assessments, provided technical assistance, and guided graduate students in the areas of environmental systems analysis, ecological theory, environmental impact assessment, environmental forecasting and land use, the connection environment / development , environment and quality of life, indicators of sustainable development, poverty, sustainable development and global scenarios, regional, national and local.
